#### ANNUAL SCHOOL BOARD REPORT

Dear Fellow Citizens of the Reedsville School District,

On behalf of the Board of Education, administration, faculty and staff, I welcome you to the annual meeting and thank you for being here tonight. Your interest in the future of the youth of our district is greatly appreciated.

Tonight, the Reedsville School Board is presenting to its citizens the proposed 2024-25 budget, which reflects a commitment to educational excellence as well as a commitment to fiscal responsibility. This budget will result in a levy of \$3,420,319.00, which is a 0.67% change from the 2023-24 tax levy of \$3,397,490.00.

This budget will result in a tax levy for the operational budget of \$3,005,000.00, for the referendum debt service budget of \$0.00, for the non-referendum debt service budget of \$90,319.00, and for the community service budget of \$325,000.00.

The 2024-25 General Fund estimated revenues are \$10,303,924.00 and estimated expenses are \$10,303,924.00.

Your Board of Education will continue to seek improvement in the educational opportunities for our children and will continue to be fiscally responsible to the citizens of this district.

Again, thank you for your interest, your support, and for being here tonight.

#### ANNUAL TREASURER'S REPORT

To meet the debt service and operating expenses for the 2023-24 school year, a gross tax of \$3,397,490.00 was levied and certified last November. Of this amount, \$2,936,564.00 was for general fund operations, \$0.00 was for referendum debt service, \$110,926.00 was for non-referendum debt service, and \$350,000.00 was for the community service fund.

At the end of the 2023-24 school year, the district had a \$1,813,486.12 general fund equity balance, an increase of \$20,051.37 from the previous year. This means that if all the revenues owed to the district were paid, and if all the expenses owed by the district were paid, the district would have a \$1,813,486.12 fund balance.

The total proposed 2024-25 General Fund revenues are \$10,303,924.00 and expenditures are \$10,303,924.00.

For the 2024-25 school year, the referendum debt service levy will be \$0.00 and the non-referendum debt service levy will be \$90,319.00. This, in addition to the Community Service Fund levy of \$325,000.00, and the General Fund levy of \$3,005,000.00 will result in a total tax levy of \$3,420,319.00. This is a 0.67% change in tax levy for the 2024-25 school year compared to the \$3,397,490.00 levied for the 2023-24 school year.

The property tax levy is based on the 2024-25 state equalized aid estimate of \$5,246,770.00 compared to the \$4,822,411.00 certified state equalized aid received during the 2023-24 school year. This results in an estimated increase of \$424,359 in state equalized aid, which is an 8.8% increase.

With the approval of the presented levy, the overall mill rate for the Reedsville School District will be approximately \$5.91 per thousand dollar valuation for the 2024-25 school year. This is a \$0.51 decrease to the mill rate for the 2024-25 school year compared to the 2023-24 school year mill rate of \$6.42, which is a 7.9% decrease.
